

**TENDER NOTICE**

**I. Annual Operation & Maintenance Contract for the E.T.P in the  
Vaidyarathnam P.S. Varier Ayurveda College Campus, Kottakkal**

Sealed tenders are invited from competent and recognized agency for the uninterrupted operation and maintenance around the clock of a newly constructed Effluent Treatment Plant with a capacity of 150 KLD for a period of **one year** in the Vaidyarathnam P.S. Varier Ayurveda College, Kottakkal, Malappuram District with the following terms and conditions.

1. The tenders should be addressed to the under signed in a sealed cover.
2. The envelopes containing the tender should bear the superscription “TENDER FOR THE ANNUAL OPERATION & MAINTANENCE CONTRACT OF THE EFFLUENT TREATMENT PLANT IN THE VAIDYARATHNAM P.S.VARIER AYURVEDA COLLEGE CAMPUS, KOTTAKKAL”.
3. The tenders may contain the documents relevant to prove the competency in the field and recognition from the Kerala State Pollution Control Board.
4. The tenders should accompany with an EMD worth ₹. 22,500/- (Rupees Twenty two thousand and five hundred only) in the form of Demand Draft drawn in favor of Chief Executive Officer, KASRS, Kottakkal from a Nationalised Bank, payable at Kottakkal and a preliminary agreement in a stamp paper worth ₹. 100/- (Rupees One Hundred only). The EMD of the unsuccessful tenderers will be returned as soon as possible after the tenders are settled, but that of the successful tenderers will be adjusted towards the security that will have to be deposited for the satisfactory fulfilment of the contract. No interest will be paid for the EMD . The State Govt. institutions etc. are generally exempted from furnishing EMD.
5. The offer shall contain the terms and conditions applicable like.
  - i) Scope of Work/Activity

ii) Manpower Deployment skilled /unskilled

iii) Scope of removal of oil/sludge and disposal

6. Man power should be supplied by the agency, both skilled as well as unskilled.
7. Chemicals/spares required should be supplied by the agency.
8. The agency should have the full responsibility to maintain the quality of the treated water as per the Kerala State Pollution Control Board norms.
9. The agency should submit Weekly Reports regarding the quality of the treated water before the management.
10. Sludge is to be removed /separated and disposed suitably by the agency as per the direction of the management.
11. The agency should operate and maintain the plant in good condition. Any damage occurred to the equipments/system shall be to the agency's account.
12. Any modification or change of process/operation parameter shall be done only with the consent of the management.
13. The quotation may specify the taxes applicable, terms of payment for the period of contract, ie, for one year
14. Intending tenderers should send their tenders either by post or by courier so as to reach the undersigned before 2.00 pm on 22/02/2011. No tender received after the specified date and time will be accepted on any account. The rate will be considered firm for acceptance till the due date. Tenders not stipulating period of firmness with price variation clause and for subject to prior sale conditions are liable to be rejected.
15. The tenders will be opened at 2.30 p.m on 22/02/2011 in the office of the undersigned in the presence of such of those tenderers or their nominees who may be present at that time.
16. The final acceptance of the tender rests entirely with the undersigned who do not bind themselves to accept the lowest or any tender.
17. The successful tenderers should be prepared to guarantee satisfactory performance of the plant for the contract period under a definite penalty.

18. The successful tenderer will execute an agreement in stamp paper worth ₹. 100/- (Rupees One Hundred only) for the due fulfilment of the contract within the period to be specified in the letter of acceptance. Failure to execute the agreement within the period specified will entail the penalties set out in para below
19. The successful tenderer before signing the agreement and within the period specified in the letter of acceptance of his tender, deposit a sum equivalent to five percent of the value of the contract as security for the satisfactory fulfilment of the contract less the amount of money deposited by him along with his tenderer. The amount of security may be deposited by way of demand draft crossed on the Canara Bank/State Bank of Travancore, Kottakkal drawn in favour of the undersigned. If the successful tenderer fails to deposit the security and execute the agreement as stated above, the EMD by him will be forfeited to KASRS Kottakkal and the contract arranged elsewhere at the defaulters risk and any loss incurred by the KASRS, Kottakkal on account of this will be recovered from the defaulters who will however, not be entitled to any gain accruing there by.
  - a) In case where a successful tenderer after having made partial work fails to fulfil the contract in full, all or part work may be entrusted by means of another tender/ quotation or any negotiation or from the next higher tenderer who had offered the work and the loss if any, caused to the Society shall thereby together with such sums as may be fixed by the undersigned towards damages be recovered from the defaulty tenderer
  - b) Even in cases where no alternate work is arranged, the proportionate portion of the security deposit or the cost of the work not done at the rate shown in the tender of the defaulter will be forfeited and balance alone shall be refundable.
20. The security deposit shall subject to the conditions be returned to the Contractor within three months after expiration of the contract, but in the event of any dispute arising between the Office and the Tenderer, the undersigned will be entitled to deduct out of the deposit or the balance thereof, until such dispute is determined, the amount of such damages cost, charges and repairs as may be

claimed.

21. The tenderer shall not under-let or sub-let to any other body corporate or person or persons for the execution of the contract or any part thereof.
22. In case any difference or dispute arises in connection with the contract, all legal proceedings relating to the matter shall be instituted in the court with whose jurisdiction the undersigned resides.
23. No representation for enhancement of rates are accepted will be considered.
24. Any attempt on the part of the tenderer or their agents to influence the undersigned will disqualify the tenderer.

Interested agencies are requested to visit the plant site in the Vaidyarathnam P.S. Varier Ayurveda College campus with prior permission of the management to provide suitable competitive offer.

Duly filled tender forms should be returned to the Society office on or before 2.00 pm on 22/02/2011 with an EMD worth ₹. 3,800/- in the form of Demand Draft drawn in favor of Chief Executive Officer, KASRS, Kottakkal from a Nationalised Bank, payable at Kottakkal and a preliminary agreement in a stamp paper worth ₹. 50/- (Rupees Fifty only).

4. The EMD of the unsuccessful tenderers will be returned as soon as possible after the tenders are settled, but that of the successful tenderers will be adjusted towards the security that will have to be deposited for the satisfactory fulfilment of the contract. No interest will be paid for the EMD .
5. Intending tenderers should send their tenders either post or courier so as to reach the undersigned before 2.00 pm on 22/02/2011. No tender received after the specified date and time will be accepted on any account.

The tenders will be opened at 3.00 p.m on 22/02/2011 in the office of the undersigned in the presence of such of those tenderers or their nominees who may be present at that time and all other procedures are in accordance with the conditions specified above from (16) to (24) in the tender notice No. I given above (Operation & Maintenance Contract of ETP in the College campus).
